VISIONARY BROADBAND AWARDED \$5.19 M GRANT IN CHAFFEE COUNTY FOR FIBER BUILD

CHAFFEE COUNTY, CO – Visionary Broadband—a provider of high-speed internet service to communities in the rural West including Colorado, Wyoming and Montana—has been awarded a CPF grant totaling \$5.19 million. Visionary will be contributing \$1.7 million of its own monies for a total project amount of \$6.92 million. The grant and subsequent match will allow Visionary to build out high-speed internet service to nearly 1,310 users in Buena Vista and Nathrop, Colorado.

Awards are from Colorado’s Advance Broadband Initiative via the Colorado Projects Fund Grant.

Visionary pinpointed 1,310 homes and businesses in the towns of Buena Vista and Nathrop in Chaffee County that suffer from slow or no internet service at all, referred to as underserved and unserved; 1271 were identified as underserved and 39 unserved. The funding will allow Visionary to provide the infrastructure for “Fiber to the Home” internet service, which is state of the art technology.

To meet the new high-speed requirements of the federal government and Colorado Broadband Office, broadband constructed with the grant funds must provide download speeds of 100 megabits per second and upload speeds of at least 20 Mbps. The old requirements were 25 Mbps down and 3 Mbps up.

Jake Rishavy, executive director of the Chaffee County Economic Development Corporation, expressed the importance of projects like this one in his rural community: “Reliable, high-speed internet is no longer a luxury. It has become a vital resource for the economic stability of a community. It impacts our ability to recruit and retain a strong workforce and the companies that create high paying jobs for locals. The work Visionary Broadband will be doing in Buena Vista and Nathrop is a win for the residents and business owners, many of whom work, educate themselves, or access health care remotely, ensuring reliable connectivity in an area that has great need.”

The projects must be completed by the end of 2026 in order to receive full funding. The Colorado Projects Fund grant application process was highly competitive. Thirteen projects were awarded \$113.5 million, out of 112 applicants seeking more than \$640 million.

Brian Worthen, CEO of Visionary applauded the state's effort: "Awarding such a large number of grants in such a short time was not a simple lift. The Colorado Broadband Office did a phenomenal job ensuring that the areas of greatest need in rural Colorado were prioritized and we are excited to get to work to deliver an exceptional product to these areas."

In Colorado, Visionary serves primarily mountain communities in western Colorado, areas where internet service has historically been difficult to provide due to the vast distances between users or the rugged, high-altitude topography of the Rocky Mountains.
